## **Birch Bay Village Marina Guest Launch**

### **Registration:**

Members must pre-register with the BBVCC Office with guest's boat and trailer registration, vehicle registration and proof of liability insurance prior to guest entry into BBVCC.

A temporary vehicle permit (Guest Launch Pass) will be issued that must be displayed on the review mirror of the vehicle attached to the boat trailer.

### **Terms and Conditions:**

Guests must supply the office with a copy of boat and trailer registration, and proof of liability insurance for the vessel being launched and/or retrieved. It is understood and agreed that guests are liable for any damage to BBV property, the environment, or other private property within the Marina.

Members are responsible for the conduct of their guests and the guest's compliance with all Marina Rules and Regulations.

Boat trailers may be parked in the launch parking area only.

**A MAXIMUM OF SIX (6) LAUNCHES PER GUEST PER YEAR.**

### **Guest Launch Fees:**

There is a \$20.00 charge for each launch and retrieval of a guest's vessel from the BBVCC Marina.

## **Birch Bay Village Marina Guest Moorage**

### **Registration:**

Guests must register with the BBVCC Office upon docking in the guest area. (BBVCC Members may pre-register their guests at the office)

A temporary vessel moorage permit (Guest Dock Pass) will be issued that must be displayed in a visible location on the vessel (such as a dock-side window).

### **Terms and Conditions:**

Guest vessels enter the BBV Marina at their own risk and it is understood and agreed that they are liable for any damage to BBV property, the environment, or other private property within the Marina.

Guest vessels may stay up to 3 days; the maximum number of non-sequential stays is three (3) per calendar year.

Rafting at the Guest Dock is NOT permitted.

Auxiliary generators (whether permanently installed in the vessel or portable) are NOT to be operated in the Marina.

Member of Yacht Clubs that have pre-arranged reciprocal agreement with the BBVCC Yacht Club are to fly their club burgee while in the marina.

### **Guest Moorage Fees:**

There is no charge for temporary moorage at the Guest Dock; however, a \$5.00 per day fee (US funds) will be required for guest vessels utilizing shore power.
