# POLICY RESOLUTION NO 10-02-19-04

PURPOSE: To Define Clubhouse Availability, Uses and Policies

WHEREAS BBVCC Clubhouse, herein known as "The Clubhouse" or "Clubhouse" is for the exclusive use and benefit of the property owners of BBVCC; (See Appendix A #B; and

#### NOW, THEREFORE, BE IT RESOLVED:

That the Clubhouse shall be used only for events of the recognized clubs of BBVCC (Art Club, Bridge Club, Golf Club, Social Club, Yacht Club, etc.); and, (See Appendix A #A)

IN ADDITION, the Clubhouse will be available to property owners/members of BBVCC in good standing under the following conditions:

- 1. Payment of a rental fee per day per the current Fee Schedule;
- 2. Payment of a security/cleaning deposit per the current Fee Schedule;
- 3. Assumption of full financial responsibility for any damages in excess of the deposit; this shall be done by a written document, duly signed and witnessed (*Appendix B*).
- 4. All fees must be paid before obtaining keys to the Clubhouse.
- 5. The party needs to abide by all rules and regulations of Birch Bay Village Community Club.
- 6. All rentals must be sponsored by a BBVCC owner/member in good standing, and the BBVCC owner/member must attend the event so sponsored.

The Management of BBVCC will accept reservations for the Clubhouse only from an officer of a recognized BBVCC club; or, in the case of a private function, reservations are accepted only from a property owner/member in good standing. The Clubhouse may <u>not</u> be used for: commercial, political, religious activities or for any other use the BBVCC Board of Directors herein known as the "Board" deems inconsistent with the well being of BBVCC (this exclusion does not include weddings and memorials).

The Board reserves the right to refuse access/use to any owner/member, non-member or for any event that the Board deems inconsistent with the well being of BBVCC.

#### APPENDIX A:

### <u>A.</u>

#### Honorary Guest Members/Guests

- 1. Requirement for Membership to any BBVCC organization is current ownership in good standing in Birch Bay Village. (see Bylaw 4.5)
- 2. No Honorary Guest Membership will be accepted for anyone who has never been an owner/member in Birch Bay Village.
- 3. Due to the occupation limits of the Clubhouse, those who may attend functions must be permitted in the following order:
  - 1) Current owners/members in good standing
  - 2) Honorary guest members
  - 3) Guests

# <u>B.</u>

# Free Use of Clubhouse under the following guidelines:

- 1. Activities/functions sponsored by BBVCC organizations, which are made available to <u>all</u> BBVCC Owner/Members.
- 2. No retail activities for profit.
- 3. All funds collected are for the specific BBVCC organization (i.e. Yacht Club, Building Fund) and/or for reimbursement for food and/or supplies used for that activity. Additional funds may be collected for the BBVCC organization's treasury. The BBVCC organization may charge a different amount for a member of that BBVCC organization (i.e. Social Club members, Yacht Club members) from the fees charged to a non-member in attendance.
- 4. All private functions (those that are not sponsored by a BBVCC organization and open to the <u>entire</u> BBVCC owners/member), even within a BBVCC organization, must pay the current Clubhouse rental and deposit fees.
