## CANINE EXERCISE AREA RULES (Additional rules posted at exercise area)

1. Dogs must be up to date on their vaccinations, as required by law and current vaccination record must be on file at the Village office.
2. Dog handlers/owners are always legally responsible for the behavior of their dog(s).
3. Dog handlers/owners must be at least 18 years of age.
4. Children 5-17 years of age allowed when accompanied by an adult; no children under 5 years of age allowed.
5. Dogs must be on a leash when entering and exiting the exercise area.
6. Dog handlers/owners must remain inside the exercise area supervising their dog with leash readily available.
7. All dog handlers/owners must be in agreement with each other to share the exercise area. Permission to enter the exercise area must be granted by handlers/owners with their dogs(s) already in the park. If permission is denied, please be respectful and return another time.
8. Only 2 dogs per professional dog handler are allowed at a time: Limit 5 dogs in the exercise area at one time.
9. Dog -waste must be cleaned up by their handler/owner immediately and deposited in trash receptacles.
10. Any holes made by your dog(s) must be covered/filled before you leave the exercise area.
11. Exercise area open from dusk to dawn.

### For the safety of all the following is NOT Permitted:

1. Glass containers or human food (small dog training treats permitted).
2. Puppies 4 months or younger.
3. Aggressive dogs\*.
4. Grooming of dogs.
5. Dogs in heat.

*\*A reactive dog with their handler/owner may use exercise area. This information MUST be disclosed and communicated to anyone wishing to enter the exercise area.*

**AGREEMENT WITH HOLD HARMLESS AND INDEMNITY PROVISIONS**

I understand and assume the risk that, despite the effort of the BBVCC HOA to ensure owners have complied, not all dogs present in the exercise area have been licensed and vaccinated for rabies as required by law which could result in injury to a human or dog.

I understand that the use of the exercise area is self-directed, and no direct supervision will be provided by agents or employees of the BBVCC HOA. The BBVCC HOA assumes no liability or loss, damage or injury of any kind incurred by any human or dog while using the dog exercise area. I understand and expressly assume all risks associated with using the canine exercise area, its fixtures and equipment, in an unsupervised and self-directed manner.

By signing this application/release of liability and using the Paws A While Canine Exercise Area, I agree to indemnify and save harmless Birch Bay Village Community Club Homeowners Association. The Birch Bay Village Community Club Homeowners Association and their agents, officers, employees and assign from and against all loses, claims, costs, damages, expenses, demands, causes of action of any kind or character and liability, present or future, whether the same be known or unknown, resulting from or arising out of my use of the canine exercise area premises, facilities, or equipment, including but not limited to, death, sickness, injury and disease to any person or dog, or destruction to property, real or personal.

I acknowledge that I have carefully read this application/release of liability, and understand, agree with, and accept its terms and conditions, and sign this application/release of liability as my own free act. I acknowledge that I have also received a copy of the rules for canine exercise area use and agree to abide by these rules, that I have been apprised of all relevant information and material relevant to this application/release of liability, including, but not limited to, future use.

*In the event of a violation of the dog park rules or terms of the application, the Board of Directors may take the following action:*

**A. Exigent Circumstances**

In the event that a dog has displayed aggressive, dangerous, or threatening behavior or has attacked, bitten or harassed a person or another dog, the Board may immediately and permanently revoke the dog owner's membership without notice. The member may request a hearing with the Board to discuss the revocation.

**B. Non-Exigent Circumstances**

1. First Offense: Warning letter and request to correct violation.
2. Second Offense: Hearing letter, request to correct violation and possible suspension of a member pass for up to 30 days.
3. Third or more Offense: Hearing letter and possible revocation of a member pass for a period of time determined by the Board. The revocation may be permanent.

Acceptance of the terms & conditions of this release and adherence to the Paws A While rules are conditions of approval, retention, and renewal of the BBVCC Paws A While dog exercise area access. Access will be revoked for noncompliance with the terms of this application.

I hereby acknowledge that I have voluntarily applied to participate and use, with my dog(s), the designated canine exercise area approved by the BBVCC Homeowners Association. I understand and acknowledge that dogs, irrespective of their training and past usual behavior or characteristics, may act or react unpredictably at times and I agree to assume that this risk may result from dogs present in the exercise area.

**BY SIGNING BELOW, I CERTIFY THAT I HAVE READ AND AGREE TO THE CANINE EXERCISE AREA RULES AND THE AGREEMENT WITH HOLD HARMLESS AND INDEMNITY PROVISIONS.**
