## **Old Business:**

# Flood Action Status-Pump Removal:

Bobby reported the pump has been removed from the lower gate and put away until next year. The gas was pumped out.

# **Review County Study:**

Bill sent additional questions to Scott with the County and is waiting to hear back.

# Gauges:

We do have extra gauges to measure the water levels in the ditch by the lower gate and ponds. We are going to wait until summer when the water levels are lower and possibly remeasure and replace a few.

# **Pump Outlet To Marina:**

There was another pipe in that area that Bill asked Bobby if it might be usable? Bobby said for unknown reasons it was filled in with concrete so that is unusable. Bobby said the pump was was running all winter. We will look into how long the life expectancy is for that pump.

# **Phosphorus Testing:**

BBV Maintenance has taken responsibility for occasional phosphorus testing since BBV discontinued its relationship with WWU's Institute for Watershed Studies a decade ago. Outside contractor then AuqaTechnex provided this testing in 2023. Our Lakes Management Plan now re-assigns this responsibility to Committee Members, to be done monthly April-September. Bill suggested a committee member accompany (BBV) Maintenance to assist, confirm testing locations and document the process.

# **EutroSORB Application Date:**

Bobby and crew plan on applying the first application around April 14. It was suggested that we test the water before and after the application.

#### **Duckweed Removal:**

We really are going to work hard to figure out how to address the duckweed build up on the golf course pond near hole 5. Jack Dyrland mentioned that he lives on hole 3 and his pond has started to have duckweed. Bobby is going to check with his vendor supplier and see what he suggests.
