## BBV Sponsored Golf Pass Rules & Conditions

**General Premise:** Anyone who is properly sponsored approved and pays for an SGP will be subject to the rules and regulations applicable to all BBV residents. SGP holders may participate in the same golf activities and events as are enjoyed by all BBV residents (except that participation in the BBV Men's Golf Club, the Friday Ladies Golf Club and Friday Night Couples Golf is subject to the independent approval of those clubs.)

### Specific Conditions and Procedures:

- **Eligibility:** SGP applicants must: a) be sponsored by a BBV resident in good standing; b) complete an application; and, c) be approved by both the BBV General Manager and the BBV Golf Shop Manager.
- **Application and sponsorship process:** Applicants must complete an application provided by and maintained at the BBV Community Club Office (see attached); payment of the annual SGP fee must accompany the application; sponsor verification is performed by BBV staff, following which the SGP application is forwarded to the BBV General Manager for approval.
- **Approval and Notification:** Applicants approved by the BBV General Manager and the BBV Golf Shop Manager are notified by BBV staff in the order that applications are received.
- **SGP Fee:**  
SGP cost = Resident "Single" Annual Golf Pass (one person, regardless of age) and is good for the calendar year only (January 1-Dec. 31)
- **Program Evaluation:** Each year, the Golf Committee shall evaluate the SGP program and recommend to the Board (during the annual budget process) that the SGP be continued (with or without changes) or terminated.

### Additional Considerations:

- **Tee-times required:** SGP holders are required to schedule tee-times in advance through Chronogolf or by calling the rec center; tee-times are subject to availability.
- **Compliance with Golf Course Rules and Regulations:** SGP holders must comply with the same BBV Golf Rules and Regulations that apply to all BBV residents and their guests (e.g., dress code, equipment, course rules, golf course etiquette, and so on); BBV office staff will provide each SGP holder with a copy of the current BBV Golf Rules and Regulations when the SGP card is issued. **Failure to comply with said rules and conditions may result in the termination of SGP privileges and the forfeiture of fees paid.**
- **Club and Social Activities:** SGP holders may participate in all BBV golf-related events and activities, except that the Men's Golf Club, the Friday Ladies Golf Club and the Friday Night Couples golf groups shall independently determine whether SGP card holders may participate in their respective organizations and events.
- **Restricted guest invitation privileges:** The SGP holder, not being a BBV resident, is not permitted to admit non-resident guests into Birch Bay Village under his/her own sponsorship.
- **Restricted use of personal motorized golf carts:** SGP holders may not trailer-in a motorized golf cart on a routine basis. A motorized golf cart can be rented from the Rec Center, or a personal cart can be left with a BBV resident for use on the golf course. In the latter case, either the annual golf cart trail fee (now \$200/year) or a day-use fee will be paid.

**Restricted tournament-sponsor privileges:** SGP holders may not directly sponsor golf tournaments held on the BBV golf course. A BBV resident, BBV staff, or the Rec Center Manager, however, can serve as a tournament sponsor that includes the SGP holder(s) and other invited guests, subject to the same requirements that apply to all BBV resident-sponsored tournaments.

## **BIRCH BAY VILLAGE COMMUNITY CLUB GOLF COURSE RULES AND REGULATIONS (Abbreviated Version)**

Only golfing activities are allowed on the Golf Course unless otherwise authorized by the Golf Committee and/or the Board.

All golfers shall be familiar with and comply with the following rules and regulations pertaining to the Golf Course:

1. All golfers using the Golf Course **MUST** acknowledge these Rules and Regulations on an annual basis.
2. Tee Time **MUST** be booked using the Rec Center's internet-based tee booking system.
3. All golfers **MUST** check-in at the Rec Center prior to starting play.
4. All golfers **MUST** have proof of payment of their green fee.
5. All golfers **MUST** start on Hole #1 unless directed otherwise by the Rec Center..
6. Golfers are expected to maintain a good pace of play, completing nine holes in 110 minutes or less.
  - a. Slow play: Slow groups/players must let faster groups/players play through if there is an open hole in front of them.
  - b. Lost balls: Time spent looking for a lost ball must not exceed three minutes.
7. All individuals must wear acceptable golf attire while on the Golf Course or practice area.
8. Golfers are responsible for any damage they may inflict to the Golf Course and related BBVCC improvements. They should also consider themselves responsible for any damage they may inflict on adjacent properties and report errant shots that may have resulted in damage to the Rec Center.
9. Inappropriate behavior on the Golf Course will **NOT** be tolerated.
10. Golfers **MUST** respect adjacent properties – do not enter or retrieve a golf ball from adjacent property without permission from the property owner.
11. Golfers **SHOULD** repair ball marks on greens, replace or fill divots with sand on fairways, fill divots with sand on tees, and rake sand bunkers as appropriate.
12. Each golfer **MUST** have their own set of golf clubs. Golf bags **MUST NOT** be placed on the surfaces of greens.
13. Golfers **MAY NOT** use the Golf Course as a “personal” practice area or driving range.
14. Golfers **MUST NOT** hit balls in the general direction of Golf Course Maintenance staff.
